Update from NAM on COVID-19 March 26, 2019

As the State Affiliate for the National Association of Manufacturers (NAM), we are partnering with them to provide updated information from the federal level on the COVID-19 issue and its impact on employers. Last night, senators came to an agreement on a "phase three" COVID-19 bill, which the Senate is expected to pass later today. The \$2 trillion relief package will provide loans to small businesses, direct financial checks to many Americans, expanded unemployment insurance and much more.

The legislation is the product of intense bipartisan negotiations, and the NAM ensured the unified voice of manufacturers was heard by policymakers as they crafted the final package. The Senate still needs to vote on the package before it is taken up by the House as early as tomorrow. Read a summary of the current understanding of key provisions <u>here</u>.

Here are some of the other recent developments:

Continuing the Effort for Essential Business Designations

The NAM continues to work with our state association partners across the country to help manufacturers continue their essential work. You can monitor this industry-wide effort <u>here</u>. Most recently, the Colorado Chamber of Commerce, the Colorado Advanced Manufacturing Association and the Denver Chamber of Commerce worked together with the NAM's field advocacy team yesterday to persuade the Denver mayor to revise a "stay in place" order so essential manufacturers could continue operating as essential business.

Across the country, we are urging states to pursue a uniform approach by adopting the Department of Homeland Security's Guidance on the Essential Critical Infrastructure Workforce, and today we joined more than 100 organizations in calling on elected leaders to adopt a common definition of critical infrastructure. We are also working with other leading business groups to encourage states to provide consistent guidance on processes and documentation requirements for these essential businesses. The NAM continues to work with the White House and the Federal Emergency Management Agency to coordinate private-sector assistance to produce personal protective equipment and other products critical to our country's response to this crisis. Labor Department Employee Paid Sick Leave Resources

As part of the Families First Coronavirus Response Act, the Department of Labor's Wage and Hour Division has announced the FFCRA's paid leave mandates will go into effect on April 1, 2020, for companies with fewer than 500 employees. They have also shared fact sheets for how this will affect <u>employees</u>, how it will affect <u>employers</u> and a <u>helpful FAQ sheet</u> for employers. The DOL has also requested that the public submit questions, concerns and recommendations for the implementation of the FFCRA. The NAM plans to submit recommendations, and we encourage you to provide feedback to help shape our suggestions.
